The draft of Goa Food Security Rules, 2015, which the State Government proposes to make in exercise of the powers conferred by

sub-section (1) of section 40 of the National Food Security Act, 2013 (No. 20 of 2013), is hereby published (as indicated in the Annexure below) for information of all persons likely to be affected thereby and notice of thirty days from the date of its publication in the Official Gazette.

Any views or suggestions, which may be received from any person with respect to the said draft rules before the expiry of the period so specified, will be decided by the State Government.

ANNEXURE

The Goa Food Security Rules, 2016

In exercise of the powers conferred by sub-section (1) of section 40 of the National Food Security Act, 2013 (No. 20 of 2013) the State Government is pleased to make the following Rules, namely:—

1. *Short title, extent and commencement.*—

(1) These rules may be called the Goa Food Security Rules, 2016.

(2) It extends to the whole of the State of Goa.

(3) It shall come into force upon its publication in the Official Gazette.

2. *Definitions.*— In these rules, unless the context otherwise requires,—

(1) “Act” means The National Food Security Act, 2013 (No. 20 of 2013).

(2) “Commission” means The Goa State Commission for Women to exercise the powers and functions of the Goa State Food Commission referred to in section 16 of the Act.

(3) Words and expressions not defined in these rules but defined in the National Food Security Act, 2013, shall have the same meaning assigned to them in the Act.

3. *Identification of Eligible Households.*— (1) Identification of Eligible Households shall be in accordance with the guidelines framed by the State Government under section 10 of the Act.

(2) The State Government may, at such intervals or any other time, it may deem fit, re-identify the eligible Households.

(3) The State Government may, if it deems fit, by notification, amend the prescribed guidelines from time to time.

4. *Grievance Redressal System.*— (A) Internal System of Grievance Redressal:—

(1) The State Government shall set up full-fledged and efficient Internal System of Grievance Redressal for speedy disposal of the complaint relating to the Act;

(2) The Internal System of Grievance Redressal may also consist of—

(a) a helpline with toll free number established for registering complaints and providing information to the public;

(b) a Web-based grievance redressal portal;

(3) The officer in-charge of Civil Supplies at Taluka or any other officer not below the rank of the Mamlatdar/Jt. Mamlatdar authorized by the Government shall be the Nodal Grievance Redressal Officer with regards to Targeted Public Distribution System at Taluka level.

(a) He shall redress all the grievances of the Ration Card holders in respect of non-receipt of entitled quota.

(b) He shall conduct inquiry and take necessary reports from the Inspector of Civil Supplies and accordingly dispose of the complaint.

(c) He shall redress the grievance so received within a maximum period of 45 days from the date of receipt of the complaint.

(4) An appeal if any against the orders of the Nodal Grievance Redressal Officer may be filed with The District Grievance Redressal Officer within a period of 30 days. Appeals filed beyond the period of limitation are liable for rejection:

Provided that the Appellate Authority may for sufficient reasons condone the delay & decide the appeal.

(B) District Grievance Redressal:—

(I) District Grievance Redressal Officer.— (1) The State Government may by Notification appoint any officer not below the rank of Dy. Collector as District Grievance Redressal Officer.

(2) The officer already appointed shall be deemed to be appointed under this rule **(1)** above.

(3) The District Grievance Redressal Officer shall, on receipt of the complaint and appeal against the order of Nodal Grievance Redressal Officer either in writing or personally or through helpline or web, cause verification of the complaint received and address the concern to rectify the instance.

(4) The District Grievance Redressal Officer shall redress the grievance so received as soon as may be but in any case within 60 days from receipt of the complaint.

(5) A quarterly report on No. of opening balance of grievances, No. of grievances received during the quarter, No. of grievances disposed of during the quarter and the No. of pending grievances at the end of quarter shall be submitted to the Director of Civil Supplies & Consumer Affairs, Panaji-Goa within a week after the end of quarter.

(II) Hearing before District Grievance Redressal Officer.— (1) The District Grievance Redressal Officer shall notify the days and time for receiving the complaints under the Act. He shall nominate an appropriate officer/employee to receive complaints grievances on his behalf.

(2) A fee of Rs. 200/- (Rupees two hundred only) shall be obtained by affixing non-judicial stamp on the application in case the complaint/appeal is filed by persons other than beneficiaries and Rs. 50/- (Rupees fifty only) for beneficiaries. The complaints/appeals filed without affixing appropriate fees are liable for outright rejection.

(3) The District Grievance Redressal Officer shall hear complaint/appeals regarding non-

-distribution of entitled food grains, and matters relating thereto.

(4) The process followed by the District Grievance Redressal Officer for the inquiry shall be as follows:—

(a) He will verify whether there is a prima-facie substance in the complaint/appeal to proceed in the matter, if not discharge the notice right away. If he is satisfied, that there is prima-facie grounds to proceed, he shall issue a notice to all the parties in the case about fixing date, time and place for the hearing;

(b) On the date fixed for hearing he shall hear the parties and take such evidence as may be given by them;

(c) If, on the date fixed by him, the defending party is absent he may proceed to enquire the matter ex parte and decide accordingly;

(d) After the enquiry, he shall make reasoned order giving directions to the concerned Taluka Officer for implementation of the order.

(5) The direction and relief that can be provided under sub-rule 3 above shall be as follows:—

(a) Direction for provision of the entitlement not provided, within such period not exceeding thirty days;

(b) Any other appropriate direction;

(c) Direct an appropriate person or representative to supervise the directions issued in the matter.

(III) Appeal against the order of the District Grievance Redressal Officer.— (1) Any person aggrieved by an order of the District Grievance Redressal Officer shall prefer an appeal before Goa State Food Commission within 30 days of the order.

(2) Such appeal shall be accompanied by such documents and a fee of Rs. 200/- by affixing non-judicial stamp on the application.

(3) Appeal filed without appropriate fees shall be summarily rejected.

(C) State Food Commission:—

(1) The Goa State Commission for Women or any other body as notified by the State Government shall be the Goa State Food Commission under the Act.

(2) Director of Civil Supplies and Consumer Affairs shall be ex officio Member Secretary and shall provide all functional administrative support to the Commission in its discharge of functions concerning the Act.

(3) A sitting fee of Rs. 800/- (Rupees eight hundred only) or any amount as may be fixed by Government from time to time shall be paid to the Chairperson and all the non-official members per sitting per day or part.

(4) The Commission shall meet formally at least once in a month in its headquarters or at its offices or at such other places as may be decided by the Commission;

(a) As per the need and importance of implementation of the Act in those places.

(b) The quorum for the meeting of the Commission shall be as per the requirement of the Women's Commission:

Provided that for a meeting of the Commission to review any previous decision taken by the Commission or for consideration of any issue which could not be decided on account of equality of votes in favour of and against the resolution proposed, the quorum for the meeting shall be all members being personally present.

(c) The Chairperson of the Commission may instruct the Member Secretary to call a meeting of the Commission to be held at such time and at such place as the Chairperson may direct or as required. In addition, any two members of the Commission may

request for a meeting of the Commission at any time by sending a written request to the Member Secretary with a copy to the Chairperson. The Chairperson shall adjudicate on such request and may convene meeting or reject the request for reasons to be recorded.

(d) The Commission shall be entitled to decide urgent matters by circulation of the paper to all the members.

(e) In case of a difference of opinion among the members of the Commission, the opinion of the majority shall prevail and the opinion of the Commission shall be expressed in terms of the views of the majority. Each member of the Commission shall have one vote only. The Chairman shall have no casting or second vote.

(f) All decisions, directions and orders of the Commission shall be in writing and shall be supported by reasons. The decisions, directions and orders of the Commission shall be available for inspection by any person. Copies of the same shall be made available on the website of the Commission or on the website of the Department of Civil Supplies and Consumer Affairs

(g) When the Chairperson of the Commission is unable to discharge the functions owing to absence, illness or any other cause, the next senior member of the Commission shall discharge the functions of the Chairperson, until the day on which the Chairperson assumes the charge of his functions.

(5) The commission shall have the following powers, in addition to the powers provided in section 20 of the Act, for performing its functions under sub-section 6 of section 16 of the Act.

(a) To hear appeal over the decisions of the District Grievance Redressal Officers. The appeal shall lie within 30 days from the date on which the decision

should have been made by or was actually received from the office of DGRO.

(b) While making a decision on the appeal or the complaint, the State Food Commission has the power to require the DGRO or any officer responsible for providing any entitlement under the Act to comply with the Provisions of the National Food Security Act, 2013—

(i) Issue of ration cards or eligibility cards upon satisfying the eligibility criteria.

(ii) Right to receive food grains at subsidized prices by persons belonging to eligible households under Antyodaya Anna Yojana (AAY) or Priority House Holds (PHH).

(iii) Implementation of various schemes for realization of entitlements under the Act.

(c) To summon DGRO or any other official involved in the implementation of the Act, against which a grievance/complaint is received or whose presence is felt necessary for disposal of any matter before the Commission.

(d) To necessitate the presence of any State Government Department officials and implementation staff for any review meeting or any other related event.

(e) To direct any official to act in pursuance of objectives of the Act or to perform any functions necessitated to implement the provisions of the Act.

(f) To decide on the appeals and complaints received and direct the appropriate authority to act accordingly.

(g) To visit and inspect any stock and delivery point, fair price shop, office of DGRO or any other office performing designated functions related to the implementation of the Act.

(h) To commission any studies or enquiries in pursuit of better understanding of the implementation, impacts of the Act and for necessary improvements in the implementation processes.

(i) All orders and decisions of the Commission shall be authenticated by the Member-Secretary or any other officer of the Commission duly authorized by it on its behalf.

5. *Vigilance Committees.*— (1) The Vigilance Committees constituted/revamped at different levels shall effectively function, on the due dates.

(2) The Vigilance Committee(s) will comprise as under:—

I. *At State level.*— The State Consumer Protection Council constituted under sub-section (1) of section 7 of the Consumer Protection Act, 1986 shall also function as the State Level Vigilance Committee under sub-section (1) of section 29 of the Act:

Provided that whenever such Council meets, to also discuss the complaints/ /grievances or undertakes a review of the implementation of the National Food Security Act it shall invite all the members of the Parliament as special permanent invitee to the State Level Vigilance Committee meeting as its ex officio Vice Chairmen.

II. *At District level.*— The District Consumer Protection Council constituted under sub-section (A) & (B) of section 8 of the Consumer Protection Act, 1986 shall also be the District Vigilance Committee under sub-section (1) of section 29 of the Act.

III. *At Taluka level.*— The Nodal Grievance Redressal Officer shall be the Chairperson of the Taluka Level Vigilance Committee who shall issue a notification constituting the Taluka Level Vigilance Committee with minimum of 5 members representing various sections as provided under section 29(1) of the Act.

IV. *At Fair Price Shop level.*— The Chairperson/Sarpanch of the local body i.e. Municipality or Panchayat shall be the Chairman of the Fair Price Shop level Vigilance Committee alongwith minimum 3 (three) elected representatives of the local body for the Fair Price Shops located within the jurisdiction of the local body.

(3) *Powers of the Committees.*— The Vigilance Committees shall perform such functions and have such powers as are prescribed under section 29 of the Act.

(4) *Meetings.*— (1) (a) The State Level & District Level Vigilance Committees shall meet at least twice in a year or more as decided by the Chairperson.

(b) The Vigilance Committees at Taluka & Fair Price Shop Level shall meet at least once every quarter.

(2) The date of the meeting shall be fixed by the Chairperson. The action taken on issues discussed in the meeting of Vigilance Committees shall be reviewed in the next meeting.

(3) A statement on number of meetings held during the financial year i. e. 31st March may be sent to the Director of Civil Supplies & Consumer Affairs, Panaji-Goa within a week after the end of financial year.

(4) The Taluka & Fair Price Shop level Vigilance Committees may also, in cases where it finds a matter to be of utmost importance, send the information to the District Grievance Redressal Officer.

6. *Social Audit.*— The Social Audits of the Fair Price Shops shall be conducted every year by the concerned local body.

7. *Keeping records in public domain.*— All the matters as far as possible, related to Public Distribution System shall be placed on the website of the Department of Civil Supplies

and Consumer Affairs for general information and awareness of the public.
